Local Street Fund – revenue increase \$2,000.00; expense decrease \$11,000.00
Major Street Fund – expense increase \$12,500.00
Storm Sewer Fund –expense decrease \$16,000.00
Sanitary Sewer O & M Fund – income decrease \$3,500.00; expense decrease \$8,000.00
Water O & M Fund –income decrease \$3,000.00 and expense decrease \$10,150.00. Motion carried.

2011 BUDGET

BOARD ACTION: Trustee Fink moved, supported by Trustee Smith, to approve the following 2011 Budget:
General Fund - revenue \$487,500.00 and expense \$481,550.00
Local Street Fund - revenue \$59,250.00 and expense \$76,900.00
Major Street Fund - revenue \$48,000.00 and expense \$50,650.00
Storm Sewer Fund - revenue \$23,500.00 and expense \$38,600.00
Sanitary Sewer O & M Fund - revenue \$79,000.00 and expense \$52,100.00
Water O & M Fund - revenue \$145,750.00 and expense \$246,950.00. Motion carried.
