ZONING AMENDMENT TO CHAPTER 15 – SIGNS

BOARD ACTION: Trustee Klein moved, supported by Trustee Fink, to amend Chapter 15 of

the Zoning ordinance as follows:

SECTION 15.3 General Provisions Related to Signs

C. **Prohibited Signs**

8. Signs located in the right-of-way of public streets or highways, except as may otherwise be permitted by the agency or governmental jurisdiction having jurisdiction over such right-of-way which includes review and approval by the Village of Fowler, or as otherwise may be permitted by this Chapter.

CONTRADICTION OF LIVESTOCK KEEPING IN VILLAGE OF FOWLER ORDINANCES

90.02 ANIMALS, KEEPING OF

The keeping, housing, raising, use or care of animals is regulated by Chapter 3, Section 3.5 of the Zoning Ordinance of the Village of Fowler.
